

Heath Park School is a fully inclusive mainstream school which is part of the Central Learning Partnership Trust serving the city of Wolverhampton. At Heath Park, all pupils are valued equally, regardless of where their abilities lie, with the school being committed to developing the best in everyone. All students are entitled to have access to a broad, balanced and relevant curriculum, which is differentiated to meet individual needs. Within its aims, Heath Park is committed to equal opportunities, with students being encouraged to achieve their full potential, whatever their academic or physical ability, through the provision of a balanced and challenging curriculum in both content and styles of learning.

Students of all ages and all abilities will:

- Be treated as individuals where their individual needs, interests and aptitudes are recognised.
- Be entitled to have an emerging or evident special educational need identified and assessed.
- Be provided with opportunities for continued growth and development so that they can increase their self-esteem and become confident.
- Receive a balanced curriculum in both content and style of delivery which allow them to make informed choices as they progress beyond the school.
- Be encouraged to achieve their full potential, whatever their abilities.
- Be encouraged to learn through a range of enjoyable and stimulating experiences in an atmosphere where students feel valued, encouraged and safe.
- Learn to take an increasing responsibility for their own learning and actions so that they will be equipped to deal with life after school.
- Be encouraged to see education as a life-long process to the benefit of all aspects of their life.

This SEND Information Report outlines information regarding the ways in which we provide support for all students with Special Educational Needs and Disabilities (SEND), in order to realise their full potential, make outstanding academic and personal progress and grow to be equipped for their future lives. Provision may change and develop over time.

The kinds of Special Educational Needs for which provision is made at the school</p>	<p>What kinds of SEND do pupils have in your school?</p>	<p>Children are identified as having SEND when they have a significantly greater difficulty in learning than the majority of children the same age or have a disability which prevents or hinders them from making use of education facilities of a kind generally provided for children of the same age in schools within the area of the Local Authority (SEND Regulations 2014).</p> <p>Students at Heath Park have a range of difficulties including Communication and Interaction; Cognition and Learning; Social, Emotional and Mental Health difficulties and Sensory or Physical difficulties.</p>
<p>2. Information, in relation to mainstream schools about the school's policies for the identification and assessment of pupils with special educational needs.</p>	<p>How do we know if a pupil needs extra help?</p>	<p>When your child first joins Heath Park, we use information from a range of sources to help identify SEND and other needs. These include information from parents/carers; primary school teachers; end of key stage 2 levels; base line testing; literacy and numeracy tests; application form information; subject teachers; specialist colleagues and external agencies.</p> <p>Our class teachers, Leaders of Learning and Heads of Year closely monitor the progress and attainment of all students, including those who have or may have SEND. The continuous monitoring of students during their time at Heath Park will further identify pupils with a special educational need. This identification may come from tutors, subject teachers, support colleagues, Heads of Year, outside agencies, parents/carers or the pupils themselves. If your child needs to be assessed we would use a range of assessments depending on the area of need. If it is thought a family needs support, we have good working relationships with outside agencies and a referral can be made to them.</p> <p>We follow a staged and graduated approach to identifying and assessing needs, using the Assess, Plan, Do, Review model. The triggers for intervention could be the teacher's, support colleagues or others concern, underpinned by evidence, about a pupil who, despite receiving differentiated learning opportunities, does not make expected progress.</p> <p>All students with SEND are on the SEND or Vulnerable Students registers which are accessible to all staff. Staff use this information to inform their lesson planning, teaching and student</p>

		learning activities. Targeted interventions are planned and delivered where appropriate. This may include small group or individual work across a broad range of activities.
3a. How does the school evaluate the effectiveness of its provisions for such pupils?	How will I know that my child is making progress? How do you evaluate provision?	<p>All students, including those with SEND, are assessed on a regular basis, in accordance with Heath Park s Assessment Policy. Teachers formally assess and review progress and attainment 5 times a year which is communicated to parents/carers by a report that is sent home on a termly basis. Additionally, parents evenings are held once a year when there is an opportunity to discuss progress, attainment and next steps. All students with an n, Health & Care Plan have an Annual Review. SEND students who are on the SEND register will also have a termly review.</p> <p>The school has a Quality Assurance process that assesses the effectiveness of Teaching and Learning for all students, including those with SEND and the outcomes of these evaluations are used to create and implement development plans for all aspects of school life. These are regularly reviewed through regular evaluation. Additionally progress and attainment data for students is analysed for effectiveness and value for money.</p>
3b. The school s arrangements for assessing and reviewing the progress of pupils with special educational needs	How do you check and review the progress of my child and how will I be involved?	<p>The school will send home 3 reports each year which will show your child s current and target levels as well as reporting on their effort, behaviour, homework and independent learning. Leaders of Learning, Heads of Year and Inclusion staff will monitor and review your child s levels and pick up on any subjects where your child is not making the right amount of progress. We will then put an intervention in place. At the next reporting time we will check whether the right progress has been made.</p> <p>We welcome the involvement of parents/carers and want to keep you up to date and involved with your child s progress. We do this through parents evenings; notes sent home; email; telephone calls; appointments made with individual teachers; Annual Reviews/termly reviews (for those on the SEND register).</p> <p>The school provides information for parents through the website; Open/Information days; Parents Evenings and letters home.</p>

The school's approach to teaching pupils with special educational needs</p>	<p>How do teachers help pupils with SEND?</p>	<p>Our teachers have high expectations of all students, including those with SEND. All teachers will be told about your child's individual needs and will adapt their lessons to meet these requirements. Teachers have experience and/or are trained in doing this. This may involve using different strategies, more practical/adaptation of resources and activities. This means your child can access the lessons fully.</p> <p>Within school there are a variety of staff roles to help us fully support your child. Where it is felt it is the right thing to do a student may be offered additional help and support, in which case you would be informed. There are a range of interventions and additional subject support which are available and should your child need this, it would be discussed with you.</p> <p>When your child is approaching the start of Key Stage 4, if we think it is needed, we will assess and apply for exam Access Arrangements according to the Joint Council for Qualifications exam regulations.</p>

How the school adapts the curriculum and learning environment for pupils with special educational needs</p>	<p>How will the curriculum be matched to my child's needs?</p> <p>How accessible is the school environment?</p>	<p>Most of our students follow a traditional curriculum, however a small number of learners have a more personalised curriculum to match their individual needs, interests and abilities. This may include option choices; additional literacy; nurture groups; intervention groups and number of qualifications studied.</p> <p>Our school is a safe and accessible building and we do our best to make it welcoming to the whole community. All safeguarding procedures and risk assessments are in place and adhered to by all staff. We have a range of different facilities to help SEND students throughout our school including a lift to access all areas; disabled toilets; ramps; wide corridors and equipment to help with reading and writing.</p> <p>An Accessibility Plan is in place and available from our school website.</p>

Additional support for learning that is available to</p>	<p>Is there additional support available to help</p>	<p>We have a wide range of staff to support pupils and address additional needs they may have, including pupils with SEND. This includes teachers; Learning Support Assistants; Pastoral Managers; the SENCo and Assistant SENCo.</p>

<p>pupils with special educational needs</p>	<p>pupils with SEND with their learning?</p> <p>How are the school s resources allocated and matched to children s special educational needs?</p> <p>How is the decision made about how much/what</p>	<p>Resources are allocated based on evidence of need and effectiveness. Students with an EHCP have resources allocated as outlined in their statement or plan. Additionality in the form of an extra teacher or Teaching Assistant is allocated, where resources allow, to support students in lessons. Staff liaise closely with them to ensure maximum effectiveness. They have a huge range of skills to offer in supporting students directly and indirectly, assisting staff and helping parents/carers.</p> <p>Students with EHCPs will have targets and strategies set out in their plans and these will be combined with the advice of the SENCo and learning support staff. Annual reviews involving the student, parents/carers, subject staff and other professionals evaluate those targets and strategies. The decision is based on evidence of need and impact.</p>

How the school enables pupils with special educational needs to engage in the activities of the school (including physical activities) together with children who do not have special educational needs</p>	<p>What social, before and after school, and other activities are available for pupils with SEND?</p> <p>How can my child and I find out about these activities?</p> <p>How will my child be included in activities outside the classroom,</p>	<p>A large range of academic and hobby/interest clubs are available at Heath Park School. They are open to all students, including students with SEND. Additionally we run a range of activities to support SEND students including Homework Club, Lunch and Break Time Social Club and Social Club after school. We also run coursework/revision sessions for older students as and when required.</p> <p>The Extra-Curricular timetable is available on the schools website. SEND Clubs are by invitation only.</p> <p>All children in the school are encouraged to take part in extra activities at break time, lunchtime and after school. Day and residential trips are open to all children and your child s specific needs can be discussed if they wish to join such a trip.</p>

Support that is available for improving the emotional, mental and social development of pupils with special educational needs</p>	<p>What support will there be for my child's overall well-being?</p>	<p>At Heath Park we take our pastoral responsibilities seriously. We pride ourselves on providing a high level of student support and guidance. One way we support our students is by assigning them to 2 form tutors where possible who will (in most cases) remain with them as they progress up the school. This provides continuity and builds a strong relationship between tutor, students and parents and allows regular individual interviews to be conducted with students.</p> <p>There are additional members of staff who are able to provide pastoral support, these include: teaching staff, Pastoral Managers and Learning Support Assistants.</p> <p>We also have excellent relationships with a number of external agencies.</p>

Information about the expertise and training of staff in relation to children and young people with special educational needs and about how specialist expertise will be secured</p>	<p>What training have the staff supporting children and young people with SEND had or are having?</p>	<p>We have a Student Support department which is made up of the Senco, Assistant SENCo, Pastoral Managers, two higher level teaching assistants and a number of other learning support assistants. Within this team we have staff who have a range of experience and training covering various SEN needs including the National Senco Qualification; PGCE Inclusion; Behaviour Support; Supporting students with ASD; ACEs; Supporting students with ADHD; Attachment and Trauma Issues, etc.</p>

		<p>Training is available to all staff, including teachers and LSAs, as the need arises and there is ongoing training for all staff as well as opportunities to further develop skills.</p> <p>Staff who are new to the school follow an induction programme which includes training and information on SEN. As a school we can call on support from specialist organisations from within the Local Authority as well as Health and Social Care Services.</p>

As a school we can access a range of services including the Sensory Inclusion Team and Disability Team. These services are contacted when necessary and appropriate, according to your child's needs. If you believe your child needs specialist equipment or other facilities please contact Natalie Nash or discuss the issue at the next review/parents evening.

The arrangements for consulting young people with special educational needs about, and involving them in, their education</p>	<p>How will my child be involved in his/her own learning and decisions made about his/her education?</p>	<p>Students are encouraged to take part in Pupil Voice activities; regularly evaluate their work in lessons; attend review meetings; contribute to target setting and reviewing and reflect on their learning and achievements by completing 'Have Your Say' documents prior to reviews.</p> <p>Annually, students with SEND complete learning passports, these passports allow students to communicate their strengths, weaknesses and aspirations with staff as well as offering details on how they like to be supported and targets that they have agreed with a member of the learning support team. This information is available to all staff via Provision Map.</p>

Alternatively please contact our Deputy Head Teacher, Fiona Welfair. The school's complaints procedure is available on the school's website.</p>

These services are contacted when necessary and appropriate, according to your child's needs. The school also works closely with Wolverhampton Council.</p> <p>If you believe your child needs support from a specialist please contact Natalie Nash or discuss at the next review/parents evening.</p>
